**Special Recall Election Results** - Clerk Howard provided the election results for the special election held on December 20, 2022. Chairman Arndt was recognized and publicly read the oath at the regular board meeting December 28, 2022.

**Plan Commission recommendation - Hale rezoning application 1385 Czech Ave, 24-1015** - Plan commission representative recommended to the town board not to object to the rezoning application. Motion by Gasienica to not object to the rezone request. Motion carried by unanimous voice vote. Signatures obtained and Clerk Howard to file with Adams County Planning and Zoning.

**Review and discussion of wages for Highway & Transfer Site** - Discussion and review of the wages by the board for Highway Patrol, Highway Part-Time, and Transfer Site staff. Motion by Arndt/Gasienica to increase the hourly rates for all three employees. Motion carried by unanimous voice vote. Details available and filed at the clerk's office by request.
