NOTICE OF SPECIAL TOWN ELECTOR MEETING - TOWN OF PRESTON

Notice is hereby given that a special town meeting of the electors of the Town of Preston, Adams County, Wisconsin will be held at the town hall located at the Town Hall, 1801 11th Ave, Friendship, Wisconsin, on the 6th day of November 2023, immediately following the completion of the Public Hearing on the proposed 2024 town budget, which begins at 6:00 p.m., for the following purposes:

To consider the adoption of a resolution by the electors at the town meeting endorsing a town board resolution which proposes that the town levy exceed the state allowable levy limit under Wis. Stat. § 66.0602, specifically a proposed tax levy which would exceed the allowable town tax levy for 2023, after adjustments, by 64.899%, for a dollar increase of \$127,000.

To approve the 2023 total town tax levy of \$322,688 (to be collected in 2024), pursuant to Wis. Stat. § 60.10(1)(a).
