Immediately following the public hearing, a Special Town Elector Meeting will be held to approve the 2024 total tax levy to be collected in 2025. **NOTICE OF SPECIAL TOWN ELECTOR MEETING - TOWN OF PRESTON**

Notice is hereby given that a special town meeting of the electors of the Town of Preston, Adams County, Wisconsin will be held at the town hall located at the Town Hall, 1801 11th Ave, Friendship, Wisconsin, on the 12th day of November 2024, immediately following the completion of the Public Hearing on the proposed 2025 town budget, which begins at 4:30 p.m., for the following purposes:

To consider the adoption of a resolution by the electors at the town meeting endorsing a town board resolution which proposes that the town levy exceed the state allowable levy limit under Wis. Stat. § 66.0602, specifically a proposed tax levy which would exceed the allowable town tax levy for 2024, after adjustments, by 42.965%, for a dollar increase of \$140,000.

To approve the 2024 total town tax levy of \$465,850 (to be collected in 2025), pursuant to Wis. Stat. § 60.10(1)(a).
